

## TLG CONFERENCE CALL SUMMARY February 9, 2006

This summary provides the salient issues. These notes are intended to capture key topics, conclusions, and next steps and not the nuances of the discussion.

### **Agenda Items:** Schedule

As both the TLG Chair and Vice Chair were unavailable, Anne Dailey led the call. She reminded everyone about the upcoming OU-2 Water Treatment PFT meeting scheduled for February 21 at the Forest Service building (Caribou Room) at 1:00 pm; and that there would be a BIF meeting that morning from 9:30 a.m. until noon at the same location. Dailey also indicated that the location of the BEIPC meeting on February 22 had been changed to the Wallace Inn, Gold Room, 100 Front Street, Wallace, Idaho.

Lloyd Brewer announced that there would be a WCAC (Washington Citizens Advisory Committee) meeting in Spokane next Wednesday, February 15 at 6:30 p.m. at the Gonzaga Law Library. He indicated that Tamara Langton would be making a presentation on the EPA Five-Year Review for the Box and Basin; and that Mike Beckwith and Zach Hedgpeth would be speaking about issues on the Spokane River.

Terry Harwood informed everyone that he would be out of the office next Tuesday, February 14 for Math Counts.

Bill Ryan mentioned that there was a possibility that the mine/mill conference call would be changed to Friday at 9:30 a.m.

Dailey then asked if anyone had additional items to discuss for the agenda. As there were none, she moved on to the round table.

### **Round Table:**

**Dailey:** Mentioned that she sent out the OU-2 documents to everyone for the final Phase I remedial action characterization report for the Bunker Hill mining and metallurgical complex. The documents included:

- Final OU-2 Conceptual Site Model;
- Statistical Analysis of OU-2 Post-Phase I Water Quality Data;
- Final OU-2 Environmental Monitoring Plan; and
- Phase I Remedial Action Characterization Report.

**Ryan:** Indicated that Rob Hanson, IDEQ, is trying to organize a Human Health PFT meeting to discuss blood lead testing, but no date has been set yet. He also mentioned that he and Hanson are working on a position paper to add a local control program for the Basin.

**Zilka:** Nothing to report.

**Harwood:** Mentioned that he sent out the BEIPC board packets last week to the commissioners, alternates and staff. He pointed out to Dailey that he was not able to post the OU-2 documents to the web, but that he would bring 40 copies to the BEIPC meeting on February 22. Harwood also indicated that he had completed the 2005 annual accomplishment report and would bring copies to the meeting. Regarding the two revised sections for the 2006 work plan, he mentioned that he had not heard any controversy on the two sections, so the Basin Commission would be able to vote on them.

**Spafford:** Nothing to report.

**Woods:** Indicated that the Post Falls crew would be conducting sampling at the southern end of the lake. Next week, benthic sampling would be conducted. Woods also mentioned that he is working full time on the draft for the lake modeling report and hopes to have it completed soon.

**Masarik:** Remarked that Don Martin (EPA, CDA) had relayed information about the ongoing mediation process for the LMP; and that the Phase I assessment had been initiated by the mediator between the various parties.

**Brewer:** Nothing to report.

**DeLange:** Asked Dailey if the OU-2 documents were available on the EPA website. Dailey replied that they were not as the files were too large to download to the web. However, she indicated that she would bring copies on CD's.
