Agenda: Upcoming TLG meeting on January 16th, 2013.

Round Table:

Lynn Daniels - Mentioned that the Corps of Engineers (COE) is still working with EPA on the design for the CTP (Central Treatment Plant) upgrade.

Jerry Boyd - Inquired about the Lower Basin (LB) PFT meeting that was held in December 2012. Rebecca Stevens said that a summary of the LB PFT meeting would be distributed soon.

Don Carpenter - Indicated that the construction completion report for the Osburn wetland mitigation project is done for the repository access road. The area will be monitored for five years.

Jeri DeLange - Nothing to report.

Dave George - Nothing to report.

Terry Harwood - Provided updates on the following: 1) Paved Roads Program - the December meetings with the local road jurisdictions went well. He has received some funding allocation requests for 1% for pre-engineering that allows the jurisdictions seed money to hire an engineering firm for planning; 2) Bruce Schuld has scheduled a Paved Roads Remediation Workshop with the road jurisdictions for February 5th and plans to invite other local and community organizations; and 3) Unpaved Roads - sampling results of the gravel roads tested from Harrison to Lookout Pass show not much contamination. Harwood talked to Ed Moreen about the data. There were only 7 or 8 contaminated road segments from the sampling program that need to be remediated and he will try to get a contract to finish the work completely this year. For remedy protection, Harwood is working on easements for rights-of-ways and reviewing the 30% Meyer Creek design.

Rebecca Stevens - Gave a brief update on the Lower Basin PFT meeting. She relayed that data collection on sediment transport is being put into the models; and that Dudley Reach might not be transporting as much material as previously thought when the 2002 ROD was issued.

Sandra Raskell - Nothing to report.

Jan Olsen - Nothing to report.

Randy Connolly - Indicated that the Spokane Tribe is in the process of reviewing the 30% design for the Midnite Mine Superfund Site.

Rebecca Stevens - Brought up discussion for scheduling the TLG meeting at the same location as the CCC meeting on January 16th. It was agreed to coordinate the arrangements for both meetings at Templin's Resort in Post Falls. The TLG meeting will be a half-day meeting from 1:00 - 4:30 p.m. followed by the CCC meeting from 6:30 to 9:00 p.m.

Don Carpenter - Provided an update on Robinson Creek. Field work is being processed for the site assessment and a mitigation plan should be completed in February.
