Paul Woods - USGS sampled the BEMP surface water stations last week, for Pinehurst - long-term avg. flow is 550 cfs but now running at about 250 cfs, sampling crews set-up to respond to any increase in flow but probability of a high flow event is extremely low; next lake sampling trip is the 1<sup>st</sup> week in April; also will be undergoing a national water quality review. 1-d sediment model is ahead of schedule so may want to a run of the area in Nick's stabilization project (Nick added that they will have post-construction design information in May; Steve Lipscomb, USGS, will contact Nick)
